# SCHEDULE C – LARGE COMMERCIAL SERVICE (Effective March 1, 2020)

## AVAILABILITY

Available to members of the Cooperative requiring more than 50 kVa of transformer capacity of service to commercial establishments, farm buildings, farm equipment, schools, public buildings, and other uses, subject to the rules of the Cooperative, or the provisions of such other rate schedules as the Cooperative may have in effect.

New services may be curtailed from time to time at the discretion of the Board of Directors. Power may be interrupted or curtailed from time to time and voltage may fluctuate depending on sources of power and system capacity.

#### TYPE OF SERVICE

Single-phase and three-phase, 60 cycles, at available secondary voltages. Motors having a rated capacity in excess of 10 horsepower must be three-phase. Voltage may vary from time to time.

### <u>RATE</u>

All kWh over Basic Service Charge @ 9.45¢ for each kWh.

Seller's current rate schedule may be changed from time to time by Seller's Board of Directors.

### BASIC SERVICE CHARGE

The basic monthly service charge under the above rate shall be \$95.00 (includes 500 kWh/month). Where more than 50 kVa of transformer capacity is required, the basic monthly service charge shall be extended by \$1.00 for each additional kVa or fraction thereof required. Where it is necessary to extend or re-enforce existing distribution facilities, the basic monthly service charge may be increased to assure adequate compensation for the added facilities.

All established/applied agreed monthly or annual basic charges will remain in effect, and, all services must be paid, whether disconnected or not, while service is in place unless written agreement states otherwise.

#### POWER FACTOR ADJUSTMENT

The consumer agrees to maintain unity power factor as nearly as practicable. Rate charges will be adjusted for consumers with 50 kW or more to correct for average power factors lower than 95 percent, and may be so adjusted for other consumers if and when the Seller deems necessary. Such adjustment will be made by increasing the rates one percent for each one percent by which the average power factor is less than 95 percent lagging.

### TEMPORARY SERVICE

Temporary service such as service to construction jobs, fairs and carnivals, shall be supplied in accordance with the foregoing rate except that the consumer shall pay, in addition to the foregoing charge, the total cost of connecting and disconnecting service less the value of materials returned to stock. A deposit in advance may be required of the full amount of the estimated bill for service, including the cost of connection and disconnection.

#### TERMS OF PAYMENT

Payments are due by the 15<sup>th</sup> of each month. If not paid by the due date, it is subject to disconnect. If delinquent upon disconnect a charge will be assessed to cover the added expense.

## FRANCHISE FEES OR TAX ADJUSTMENTS

The amount of any franchise fees or franchise taxes levied by any quasi-municipal entity shall be added to the above charges for electricity sold within the area where such fee or tax is imposed.
